Tuition Fees include :

Tuition, text books, fruit snacks, stationery and materials, outings connected to class work as well as IGCSE and IB related costs. Lunch is included for students in Classes Transition to Class 9. For classes 10 to 13 lunch is an optional extra.

CONDITIONS OF PAYMENT

Tuition Fees are payable in three instalments. These are payable by the following dates :

By **March 21st, 2008** 20 % of the annual fees, paid as a non-refundable deposit to secure a place in the class.

By **July 18th, 2008** 30 % of the annual fees.

By **January 12th, 2009** 50 % of the annual fees.

It is understood that the enrolment of a student is for the full school year and that tuition is therefore payable on a whole year basis. Any exception to this rule is explained under the paragraph headed "Cancelled Registration & Withdrawal".

School fees for the first semester must be paid before students start in September.

N.B : There cannot be any refund of fees due to absence for whatever reason.

Late Payment Charge

Invoices will be sent out by the beginning of the month in which payment is due. The school will charge a late fee of 5 % on each over-due instalment. This amount will cover interest and administrative costs.

Failure to Pay Invoices

The school reserves the right to refuse entry to class and final examinations, and to withhold diplomas, reports and transcripts for students whose invoices are not settled within 21 days of the due date.

ENTRY OF A STUDENT DURING THE SCHOOL YEAR

In exceptional circumstances the school may accept a student for a period shorter than a school year. For such students the Registration Fee and the Capital Development Fund Fee are required in full. The tuition fees will be prorated and calculated on an individual basis.

FEES FOR NEW STUDENTS

Registration Fee

A Registration Fee of 1500€ must accompany the Enrolment Agreement which is only sent when a place has been officially offered. This is a one-time, non-refundable payment for all new students. A place in the school is secured only after the Registration Fee is received and the Enrolment Agreement signed.

Capital Development Fund Fee

This fee of 5000€ per new student is paid once only and is non-refundable. It is used for the continual improvement and upgrading of the school and is billed at the same time as the first installation of tuition fees.

RE-ENROLMENT

Parents will be sent the re-enrolment form for the following school year in February. Places for students will only be secured after the Re-Enrolment Agreement has been signed and the 20 % Deposit Fee Payment received. See paragraph " Conditions of Payment " .

CANCELLED REGISTRATION & WITHDRAWAL

Cancelled Registration of New Students

All notification of cancelled registration must be sent in writing to the Director. Under no circumstances will the Registration Fee and the Capital Development Fund Fee be refunded.

Withdrawal of a student during the School Year

Notification of the withdrawal of a student during the school year must be made in writing, to the Director, two months before the departure date. No reimbursement of fees will be made.

FINANCIAL AID

A 10 % discount is offered on the fees of the third child, 15 % on the fees of the fourth child and 20 % on the fees of the fifth child.

MEMBERS OF THE ASSOCIATION

The Statutory membership fee, which automatically makes each family a member of the School Association, is included in the Tuition Fees.
